Permits are available to both residents and non residents of NH. You must hold a **valid, current** New Hampshire Hunting (Regular Firearm or Archery) license to apply for a Unit M Antlerless Deer Permit. **Limit of one Unit M Permit per hunter.** Incomplete, illegible and duplicate applications will not be considered.

There will be 4,000 Unit M Antlerless Deer Permits issued.

- The Permit is for an **antlerless deer only.**

Fis 301.01(a) "Antlered deer" means a deer which has at least one antler 3 inches long measured from the tip of the main beam along the distal edge of the antler to the base of the antler burr at the skull.

The Permit is valid in **Wildlife Management Unit M only.**

An antlerless deer may be taken during the **entire Unit M season** with this permit. You can use this permit during the archery, muzzleloader or firearms season by any legal method as follows:

- An archery license is required to take a deer with a bow and arrow during the archery Season – **Unit M permits may only be used during the archery season from Oct 1 – Dec 15**
- A muzzleloader license and a regular hunting (firearm) license are required to take a deer with a muzzleloader during the muzzleloader season.
- A regular hunting (firearm) license is required to take a deer with a firearm during the entire regular firearm season (**you can still use the Unit M Permit from 11/20 thru 12/5**).

A Unit M Antlerless Deer Permit is required for hunters of all ages, including minors less than 16 years of age and hunters holding permanent licenses (Lifetime, Over Age 68, Disabled Veteran or Paraplegic). Minors under 16 years of age must be accompanied by a properly licensed adult.
